- 4) Latest I. T. return submitted with PAN.
- 5) Copies of valid trade license.

Financial Bid:-

- 1) Financial bid will contain rate of AMC.
- 2) The Authority reserves the right to terminate all or any quotation(s) the contract any time without showing any reason thereof.
- 3) Last date of submission of tender is 11.04.2014 up to 2.30 p.m. Tender documents be prepared in two sealed covers for Technical bid & Financial bid. These sealed covers will again be sealed in a big cover noting as "Tender for Annual Maintenance Contract of Extension lines with Telephone receivers" along with Tender notice No. and date.
- 4) The big sealed cover be dropped in the drop box placed for the purpose in the Ground floor of the Main Building.
