In exercise of the power conferred by Section 87A of West Bengal Value Added Tax Act, 2003 read with sub rule (1) rule 149A of the WB VAT Rules, 2005 and in terms of the Notification Nos. 1054-FT & 1055-FT both dated 23.06.2022 issued by the Finance Department in this regard, a Fast Track Revisional Authority is hereby constituted.

The Fast Track Revisional authority, so constituted, shall comprise of 7(Seven) Benches designated as Bench -I, Bench -II, Bench -III, Bench -IV, Bench -V, Bench -VI and Bench-VII with the members named in the Table below.

Bench-I to Bench-VI shall function from the Cell located at the 8th Floor, Main Building, 14 Beliaghata Road, Kolkata 700 015 and Bench-VII shall function from the office of the Appellate & Revisional Board, Himachal Vihar, Matigara, Siliguri, District Darjeeling.

The Special Commissioners of Sales Tax and Additional Commissioners of Sales Tax mentioned above shall function as such members of the said authority in addition to the work already allotted to them.

The senior most Member of each of the Benches shall preside over the proceedings of the respective Bench.

In case where any Member of any Bench of the said authority is unable to discharge his functions owing to absence, illness or for any other reason or when a Member of the said authority resigns, retires or is withdrawn or transferred, any Member from the Reserve shall function as member of such Bench.

The authority shall start functioning w.e.f. 11-07-2022.


