**CIRCULAR**

*Sub : West Bengal Industrial Promotion (Assistance to Industrial Units) Scheme – 1994.*

By virtue of Notification No. 483 FT dated 31.3.2010, West Bengal Industrial Promotion (Assistance to Industrial Units) Scheme, 2010 [in short WBIPS 2010] has replaced the West Bengal Industrial Promotion (Assistance to Industrial Units) Scheme, 1994 [in short WBIPS 1994] on and from 1.1.2010. It is, therefore, clear that the WBIPS 1994 was in operation upto 31.12.2009.

It becomes necessary in this connection to let every assessing authority know that the applications for refund which have already been filed by the dealers under WBIPS – 1994 and pending for disposal and which are likely to be filed for quarter ending December, 2009 within 30.4.2010 must be disposed of within 31.5.2010 so that the certificates, so prepared by the assessing authority, should be forwarded to PPU within 30.6.2010 positively. Senior JCCT/Circles are, therefore, requested to take stock of the situation and regularly monitor the progress of the submission of the cases to the office of CCT/WB. Sr. JCCT/Circles are requested to screen all the certificates prepared by assessing authorities and to see that only fit cases are forwarded to the office of CCT/WB. All unfit cases will have to be corrected and be sent later on. Everybody connected with this procedure should remember that we all have to begin on a clean slate on and from 1.7.2010 without any backlog with us.
