**Subject: Creation of Zones under different Units of Bureau of Investigation
and jurisdiction of officers posted therein**

In exercise of the powers conferred upon me in terms of Notification No. 795-F.T. dated 15.06.2018 under the West Bengal Value Added Tax Act, 2003, for creation of different Zones under the Units of Bureau of Investigation, and in partial modification of earlier office orders issued in this regard, the following Zones are considered to be necessary for discharging the functions of Bureau of Investigation under the said Act:

(i) Bureau of Investigation – Unit 1, shall have the following Zones:-

- (a) Bureau of Investigation – Kolkata Zone A, to investigate transactions of dealers and tax payers under Large Taxpayer Unit;
- (b) Bureau of Investigation – Kolkata Zone B, to investigate transactions of dealers and tax payers under Kolkata (South) Circle and Chowringhee Circle;
- (c) Bureau of Investigation – Kolkata Zone C, to investigate transactions of dealers and tax payers under Dharmatala Circle and Behala Circle;

(ii) Bureau of Investigation – Unit 2, shall have the following Zones:-

- (a) Bureau of Investigation - Burrabazar Zone, to investigate transactions of dealers and tax payers under the Burrabazar Circle;
- (b) Bureau of Investigation - Salt Lake Zone, to investigate transactions of dealers and tax payers under the Kolkata (North) Circle and 24 Parganas Circle;
- (c) Bureau of Investigation - Howrah Zone, to investigate transactions of dealers and tax payers under the Howrah Circle and Bally Circle;
- (d) Bureau of Investigation - Kharagpur Zone, to investigate transactions of dealers and tax payers under the Midnapur Circle;
- (e) Bureau of Investigation - Berhampore Zone, to investigate transactions of dealers and tax payers under the Berhampore Circle.

(iii) Bureau of Investigation – Unit 3, shall have the following Zones:-


- (a) Bureau of Investigation - Asansol Zone, to investigate transactions of dealers and tax payers under the Asansol Circle;
- (b) Bureau of Investigation - Durgapur Zone, to investigate transactions of dealers and tax payers under the Durgapur Circle;

(iv) Bureau of Investigation – Unit 4, shall have the following Zones:-

- (a) Bureau of Investigation - Siliguri Zone, to investigate transactions of dealers and tax payers under the Siliguri Circle
- (b) Bureau of Investigation - Alipurduar Zone, to investigate transactions of dealers and tax payers under Jalpaiguri Circle;

(c) Bureau of Investigation - Maldah Zone, to investigate transactions of dealers and tax payers under Raiganj Circle.

1. Officers posted in different Zones and in the Units of the Bureau of Investigation shall have jurisdiction in the matter of investigation into transactions of all dealers within the jurisdiction of different Zones in the respective Unit of the Bureau of Investigation.
2. The Officers posted in different Zones and in the Units of the Bureau of Investigation shall have jurisdiction all over West Bengal for the purpose of checking, enquiry, investigation, detention, search, seizure, imposition of penalty, demand of security and all related matters as envisaged under the said Act in connection with or incidental to transportation or movement of goods into, within, out of, and through the State by any person including dealer, casual dealer or transporter, or in respect of storage of goods.
3. This order shall come into force with immediate effect.


